

MSAAH Membership Policy

1. Purpose

This Membership Policy outlines the categories, fees, eligibility criteria, benefits, and governing terms for individuals seeking membership in the Myanmar Society of Aesthetics, Aging Control Medicine and Hair Transplantation (MSAAH). The policy aims to promote transparency, uphold professional standards, and ensure consistent administration of membership privileges.

2. Membership Eligibility

2.1 Who May Apply

Membership is open to the following categories of licensed healthcare professionals:

- Registered medical doctors
- Specialist medical practitioners
- Dentists

Applicants must be actively practicing in one or more of the following disciplines:

- Aesthetic Medicine
- Anti-Aging Medicine
- Hair Transplantation

2.2 Important Eligibility Notice

- Approval of membership does not guarantee eligibility to participate in all MSAAH courses, workshops, or training programs.
- Each program may have specific entry requirements, and certain workshops may be restricted exclusively to medical doctors or certain specialties.
- Applicants are responsible for reviewing program-specific criteria prior to application.

2.3 Application Review Timeline

- Standard membership applications typically require several days for review and verification following submission.
- Applicants will be informed of approval status or any additional documentation required.

3. Membership Categories and Fees

3.1 Standard Membership

- Fee: 150,000 MMK
- Duration: One (1) year
- Benefits:
 - Access to all MSAAH webinars
 - Up to 10% discount on selected MSAAH courses, events, and services
 - Access to MSAAH official updates, academic information, and member announcements
 - Networking Opportunities: Participation in MSAAH events and access to educational documents that promote professional connections and knowledge exchange
 - Global Knowledge Exchange: Opportunities to engage in international sharing of professional insights, clinical practices, and advancements within the sector

3.2 Premium Membership

- Fee: 300,000 MMK
- Duration: Three (3) years
- Benefits:
 - Access to all MSAAH webinars
 - Up to 20% discount on selected MSAAH courses, events, and services
 - Priority access and early registration privileges for MSAAH programs
 - Premium Member status recognition

- Networking Opportunities: Priority participation in MSAAH activities supporting professional engagement and collaborative learning
- Global Knowledge Exchange: Enhanced access to international academic partnerships, advanced industry insights, and global professional collaboration

4. Webinar Access Policy

4.1 Webinars Prior to May

All webinars organized before the month of May are offered free of charge to all members, both Standard and Premium.

4.2 Webinars After May

Beginning in May:

Webinars may be subject to fees depending on classification (local or international).


Discounts apply as follows:
